OUR MANDATE

The Postsecondary Education Quality Assessment Board (PEQAB or the "Board") was incorporated under the *Post-secondary Education Choice* and *Excellence Act, 2000*. Under sections 5 and 7 of the Act, the Board is empowered

- To review applications for consent and renewal of consent and other matters referred to it by the Minister under the Act and to make recommendations to the Minister
- To establish criteria and procedures for reviewing applications and other matters referred to it by the Minister and for making recommendations to the Minister
- To undertake reviews of program quality and organizational capacity
- To establish review panels to assess the educational quality of proposed degree programs in Ontario and to review applications made under the Act
- To establish advisory committees to assist the Board in providing recommendations and advice to the Minister
- To undertake such research as it determines necessary to carry out its duties.

To implement this Mandate, the Board has established its own Standards, benchmarks and procedures to review the quality of postsecondary education with the proviso, identified in the Act, that these criteria must be those "recognized in Ontario and other jurisdictions." The Board assesses programs against standards originally developed by PEQAB itself and later incorporated into what are now the degree-level standards in the Ontario Qualifications Framework and in the Canadian Degree Qualifications Framework. PEQAB's criteria also correspond to other procedures and standards enunciated in the Canadian "Ministerial Statement on Quality Assurance of Degree Education in Canada, 2007," including provisions for fairness, transparency, the use of expert panels of reviewers and the opportunity for institutions to respond to reviews prior to Board decisions. These criteria and processes sustain PEQAB's Vision: A stronger Ontario through high quality postsecondary student learning outcomes, and by PEOAB's Values: Accountable; Impartial; Collegial; Transparent; Dedicated to Quality & Continuous Improvement; Grounded in Research, Evidence & Best Practice. Both Vision and Values are highlighted on PEOAB's website and enunciated in every agenda package considered by the Board.

CHIEF EXECUTIVE OFFICER'S MESSAGE

On behalf of the Postsecondary Education Quality Assessment Board (PEOAB) and its Secretariat, I am pleased to introduce PEOAB's 2024 Annual Report.

This Annual Report details PEQAB's activities from January 1, 2024 to December 31, 2024. During the reporting period, the Board held eleven (11) regular meetings and made fifty-two (52) recommendations to the Minister on applications for consent. Of these recommendations, forty-one (41) were in respect of Ontario Colleges, one (1) was in respect of other public postsecondary institutions, and twenty-one (21) were in respect of private institutions. The Board also considered fifteen (15) Reports on Conditions of Consent.

The Board's processes are managed by a Secretariat supported by the Ministry of Colleges and Universities. PEQAB Secretariat staff continue to strengthen Ontario's relationship with the broader quality assurance community by facilitating a monthly conversation amongst all the major quality assurance agencies nationally and by participating in international postsecondary education quality assurance conferences. These both support and are supported by the Secretariat's engagement with relevant research projects.

I would like to thank members of the Board for their dedication, insights, collegiality and measured consideration of applications over the course of 2024, during which they not only met for the 11 regularly scheduled meetings but also prepared by reading in advance agenda packages, averaging in the 500 page range and above. Members also made themselves available for several email-only votes on relatively straightforward matters.

PEQAB'S PERENNIAL GOALS

In addition to the annual goals—goals developed on an annual basis and unique to each reporting year—the Board has also identified ongoing, year -over-year goals which are incorporated into standard operating practice. These goals are restated here, followed by details of performance in 2024.

1. Maintaining Client Satisfaction Levels

Maintain exceptional levels of client satisfaction, as determined by the Board's multiple ongoing Client Satisfaction Surveys. Specifically,

- a) Maintain an average of 90% or above for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's post-review Client Applicant survey.
 - **2024 Performance: Met.** As detailed on pages 10-11, PEQAB maintained an average above 90% for the combined answers 'satisfied' and 'very satisfied' for all questions in the post-review Client Satisfaction Surveys.
- b) Maintain an average of 90% or above for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's External Expert Panel survey.
 - **2024 Performance:** As detailed on pages 12 –13, PEQAB maintained an average above 90% for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's surveys of External Expert Panels.

2. Maintaining Publication Schedule

- a) Publish new Manuals incorporating revisions to PEQAB's website in each reporting year.
 - **2024 Performance:** PEQAB produced new editions of its Manuals in April and August, including a new Manual for Ontario Colleges: Applied Master's Degrees.
- b) Publish the Board's Annual Report in the January following each reporting year.
 - **2024 Performance:** PEQAB's Annual Report for 2023 was published to the Board's website on January 31, 2024.

${\bf 3.} \ \ Engaging \ with \ the \ Quality \ Assurance \ Community \ of \ Practice$

- a) Continuously monitor best practices from national and international quality assurance bodies.
 - **2024 Performance:** PEQAB remains actively engaged with quality assurance internationally, including through its membership in the International Network of Quality Assurance Agencies in Higher Education (INQAAHE).
- b) Participate in provincial, national and international discussions, meet ings and conferences related to quality assurance.
 - **2024 Performance:** As detailed on page 35-38, PEQAB remains actively engaged in national and international quality assurance conferences including the CEO's facilitation of monthly meetings among all the major Canadian quality assurance agencies, via videoconference.

PEQAB'S ANNUAL GOALS FOR 2024

- 1. External Review: Consistent with international best practice, PEQAB will complete, as per its commitment to a regular cycle of approximately every seven years, an external assessment of its practices through an independent review conducted by the International Network of Quality Assurance Agencies in Higher Education (INQAAHE). This review will be conducted on the basis of its recently published INQAAHE International Standards and Guidelines for Quality Assurance Agencies in Tertiary Education.
- 2. Enhanced Privacy Provisions: PEQAB will further update its procedures and policies as they relate to the collection, use and retention/deletion of personal information, particularly as these procedures apply to faculty curricula vitae.
- 3. Increased Involvement in Expedited Site-Visits: At the request of stakeholders, PEQAB staff will participate with the Program Evaluation Panels appointed by applicants to provide an expert orientation to PEOAB Standards, benchmarks and processes at the outset of the Expedited Review. PEQAB staff will remain available to these Panels throughout the Review process to provide guidance on the interpretation and application of its benchmarks. The PEQAB Secretariat will attend all such Reviews.
- 4. Contribute Scholarly Research on Quality Assurance: PEQAB will contribute to the global conversation on the development of theory and best practice in higher education quality issues through scholarly research activities, including a participating in a global study of higher education quality assurance lead by INOAAHE and by contributing at least one academic article.

REPORTING ON THE PEQAB'S ANNUAL GOALS: 2024

- 1. External Review: Consistent with international best practice, PEQAB will complete, as per its commitment to a regular cycle of approximately every seven years, an external assessment of its practices through an independent review conducted by the International Network of Quality Assurance Agencies in Higher Education (INOAAHE). This review will be conducted on the basis of the recently published INOAAHE *International Standards and* Guidelines for Quality Assurance Agencies in Tertiary Education. Performance: In November 2024, PEQAB completed its Self-Study and submitted its application based upon INOAAHE's International Standards and Guidelines for Quality Assurance Agencies in Tertiary *Education* for external review. The site visit for the external review of PEQAB by an independent INQAAHE appointed Panel is now scheduled for March 2025.
- 2. Enhanced Privacy Provisions: PEOAB will further update its procedures and policies as they relate to the collection, use and retention/deletion of personal information, particularly as these procedures apply to faculty curricula vitae. **Performance:** The PEQAB Secretariat has modified several processes related to its use and retention/deletion of personal information. These modifications include directing External Expert Review Panels through their appointment letters to delete consent applications including faculty curricula vitae—once reviews are complete. The PEQAB Secretariat has also updated its Operations Manual to include the deletion of faculty curricula vitae from consent applications upon the completion of a program review.
- 3. Increased Involvement in Expedited Site-Visits: At the request of stakeholders, PEOAB staff will participate with the External Expert Review Panels appointed by applicants to provide an expert orientation to PEQAB Standards, benchmarks and processes at the outset of the Expedited Review. PEOAB staff will remain available to these Panels throughout the Review process to provide guidance on the interpretation and application of its benchmarks.

- Performance: PEQAB revised its Manual for Expedited Reviews to require of any College or other institution anticipating such a Review to have prior contact with the PEQAB Secretariat for its involvement. The Manual now also requires that the institution use Panel Guidelines provided by the Secretariat and give PEQAB Senior Policy Advisors early input into the timing of their Program Evaluation Committee (PEC) Review. PEOAB Senior Policy Advisors are now also strongly suggested for input into the orientation of the PEC.
- 4. Contribute Scholarly Research on Quality Assurance: PEQAB will contribute to the global conversation on the development of theory and best practice in higher education quality issues through scholarly research activities, including a participating in a global study of higher education quality assurance lead by INQAAHE, and contributing at least one academic article.
 - **Performance:** As detailed on pages 35-38, PEQAB remains actively engaged in national and international quality assurance conferences. PEOAB also participated and contributed to a number of scholarly activities this year, including chairing INQAAHE Network webinars, engagement with the Global Academic Integrity Network, and engagement in other scholarly and professional working groups, conferences and networks. PEQAB staff are leading the North American section of Global Study on Quality Assurance, which surveyed internal and external quality assurance bodies, lead focus groups and conducted data analysis. The material will contribute to a Brill-Sense publication in 2025. An article published in the CD Howe Policy Briefs outlined the need for quality assurance of microcredentials.

ESTABLISHING PEQAB'S ANNUAL GOALS FOR 2025

- **1. External Review:** Receive and review the results of the INQAAHE *International Standards and Guidelines for Quality Assurance Agencies in Tertiary Education* for the review of PEQAB as a quality assurance agency. Implement relevant results in the spirit of PEQAB's value of continuous improvement.
- **2. PEQAB Policies**: Expand the number of policies posted on the PEQAB website: Postsecondary Education Quality Assessment Board .
- **3. Terms of Reference:** Work with the Ministry to revise PEQAB's current Terms of Reference (2023 TOR) and to finalize a new TOR aligned with the Ontario Public Service's new TOR Template for Agencies.
- **4. System Coordination:** Work with the Ministry to finalize a consistent process for determining Economic Need and Nonduplication in the form of a System Coordination Review which can be concluded in advance of requiring a full Program Review or Organization Review application.
- **5. Micro-credentials:** Work with the Ministry and with other Ontario quality assurance agencies, including the Ontario Universities Council on Quality Assurance, the Ontario College Quality Assurance Service, and the Indigenous Institutes Quality Assurance Board to establish a common approach to the quality assurance of micro-credentials, consistent with PEQAB's Recommendation: *Ontario Micro-Credentials: Harnessing the Potential.*

PERFORMANCE MEASURES

The following performance measures track PEQAB's performance year over year, against its Perennial (1 & 2) and its Annual (3) Goals.

1. Satisfaction Levels

OTHER ACCOMPLISHMENTS: 2024

In 2024, PEQAB completed the following initiatives and enhancements.

- 1. Applied Master's Degrees at Ontario Colleges: Developed Program Quality Standards and benchmarks for Master's degrees in applied areas of study to be offered by Ontario Colleges reflecting ministerial direction and principles of quality as outlined in the Ontario Qualifications Framework. Created and published all necessary PEQAB Manuals (French and English) and guidelines for use of Ontario Colleges and Expert Reviewers.
- **2. French Language Resources:** Developed PEQAB website content in French, created updated French-language PEQAB Manuals, guidelines, and other resources for use of French-speaking institutions, Reviewers and other stakeholders.
- **3. French Language Programs:** Quality assured the most French language programs in a single reporting year since PEQAB's inception with site visits, Panel Reports and Responses conducted entirely in French.

PEQAB TIMELINES

PEQAB timelines for the review of applications are calculated from the application's *referral* to its *Recommendation* date, and are reported here based on the calendar year in which the Board makes its Recommendation. Timelines are averaged and exclude delays in Review processes as initiated or approved by applicant institutions.


PEQAB SATISFACTION SURVEYS

Results from PEQAB's client survey demonstrate the level of satisfaction among educational institutions and independent academics who review the quality of degree level programming offered in Ontario.


APPLICANT SURVEY

Q1: How satisfied were you with the **quality** of the guidance, feedback and responses you received from PEQAB Secretariat staff?




Q2: How satisfied have you been with the **timeliness** of the response you received from PEQAB Secretariat staff?






Q3: How satisfied have you been with the Secretariat's choice of Expert Reviewers?













Q1: How satisfied have you been with the **quality/usefulness** of the support you received from PEQAB Secretariat staff?






