OUR MANDATE

The Postsecondary Education Quality Assessment Board (PEQAB or the "Board") was created by the Post-secondary Education Choice and Excellence Act, 2000. Under sections 5 and 7 of the Act, the Board is empowered to

- Review all applications referred by the Minister for consent under the Act
- Establish the criteria and procedures to determine the quality of postsecondary programs
- Undertake reviews of program quality and organizational capacity
- Create subject matter expert review panels, organizational review panels and advisory committees
- Undertake research as appropriate
- Provide recommendations to the Minister on applications
- Address any other matter referred to the Board by the Minister.

To implement this mandate, the Board has established its own Standards, benchmarks and procedures for quality reviews with the provision, identified in the Act, that PEQAB's Standards must be those "recognized in Ontario and other jurisdictions." The Board assesses programs against standards originally developed by PEQAB itself and later incorporated into what are now the degree standards in the Ontario Qualifications Framework and the Canadian Degree Qualifications Framework. PEQAB's criteria also correspond to other procedures and standards enunciated in the Canadian "Ministerial Statement on Quality Assurance of Degree Education in Canada, 2007," including provisions for fairness, transparency, the use of expert panels of reviewers and the opportunity for institutions to respond to reviews prior to Board decisions.

CHIEF EXECUTIVE OFFICER'S MESSAGE

On behalf of the Postsecondary Education Quality Assessment Board (PEQAB) and its Secretariat, I am pleased to introduce PEQAB's 2022 Annual Report.

This Annual Report details PEQAB's activities from January 1, 2022 to December 31, 2022. During the reporting period, the Board held twelve (12) regular meetings and made fifty-six (56) recommendations to the Minister on applications for consent. Of these recommendations, thirty-five (35) were in respect of Ontario Colleges, three (3) were in respect of other public postsecondary institutions, and eighteen (18) were in respect of private institutions.

I would like to thank members of the Board for their dedication, insights, collegiality and measured consideration of applications over the course of 2022:

Quality assurance practices are constantly evolving, and the Board is dedicated to quality and continuous improvement. During the reporting year, the Board implemented a number of significant changes which demonstrate its commitment to quality across Ontario's degree granting institutions. Chief among these changes: the Board received direction from the Minister of

Colleges and Universities to implement quality assurance review criteria and processes for a new credential for Ontario Colleges, a three-year baccalaureate degree. PEQAB made the new Manual with these criteria available as of June 2022, subsequently commenced review of four (4) such applications and finalized a recommendation to the Minister on one (1) prior to year end 2022.

As of March 2022, the Board began providing information to the Ministry from the perspective of "system coordination." Consent applications from private and out-of-province applicants are now additionally reviewed by PEQAB based on the proposed degree program's evidence for economic need, as well as for the non-duplication of existing postsecondary programs - as now are all Ontario Colleges 'proposals for three-year degrees.

The Board's processes are managed by a Secretariat supported by the Ministry of Colleges and Universities. PEQAB Secretariat staff continue to strengthen Ontario's relationship with the broader quality assurance community by facilitating a monthly conversation amongst all the major quality assurance agencies nationally and by participating in international postsecondary education quality assurance conferences. These both support and are supported by the Secretariat's engagement with relevant research projects. In this connection, the Board is especially pleased to note that PEQAB Secretariat staff member, Dr. Mary Catharine Lennon, was reappointed as Research Associate to the Center for Canadian and International Higher Education at the University of Toronto for a two-year term.

PERENNIAL GOALS

In addition to the annual goals – goals developed on an annual basis and unique to each reporting year – the Board has also identified ongoing, year-overyear goals which are incorporated into standard operating practice. These goals include:

1. Maintaining Client Satisfaction Levels

Maintain exceptional levels of client satisfaction, as determined by the Board's multiple ongoing Client Satisfaction Surveys. Specifically,

- a) Maintain an average of 80% or above for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's post-site visit survey.
 - **2022 Progress:** As detailed on pages 10-11, PEQAB maintained an average above 80% for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's post-site-visit survey.
- b) Maintain an average of 90% or above for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's post-review survey.
 - **2022 Progress:** As detailed on pages 12-13, PEQAB maintained an average above 90% for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's post-review survey.
- c) Maintain an average of 90% or above for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's External Expert Panel survey.
 - 2022 Progress: As detailed on pages 14-15, PEQAB maintained an average above 90% for the combined answers 'satisfied' and 'very satisfied' for all questions in PEQAB's surveys of External Expert Panels.

2. Maintaining Publication Schedule

- a) Publish revisions to the Board's Manuals and accompanying Summary of Changes to PEQAB's website in each reporting
- b) Publish the Board's Annual Report in January following each reporting year.

2022 Progress: The Board maintained its publication schedule for Revisions to its Manuals and Summary of Changes. PEQAB's Annual Report was published to the Board's website in January, 2023.

3. Engaging with the Quality Assurance Community of Practice

- a) Continuously monitor best practices from national and international quality assurance bodies.
- b) Participate in provincial, national and international discussions, meetings and conferences related to quality assurance.

2022 Progress: As detailed on page 34-35, PEQAB is actively engaged in national and international quality assurance conferences including the CEO's facilitation of monthly meetings among all the major Canadian quality assurance agencies, via videoconference.

ESTABLISHING PEQAB'S ANNUAL GOALS FOR 2023

- 1. External Quality Review of PEQAB as a Quality Assurance Agency Engage the International Network for Quality Assurance Agencies in Higher Education (INQAAHE) to conduct a full external expert quality review of PEQAB as a quality assurance agency. This regular feature of PEQAB's practice occurs every five to seven (5-7) years and is due this year.
- 2. Micro-Credentials: Develop a quality assurance framework for micro-credentials offered throughout Ontario's postsecondary sector through consultation with Ontario's other quality assurance agencies and other stakeholders and make a recommendation to the Minister.
- 3. Modify PEQAB's Client Satisfaction Survey Process: Develop and administer annually one comprehensive survey, available to all applicants who have undertaken PEQAB's quality assurance process in a reporting year.
- 4. Post Pandemic Site-Visits: Work with applicants to accommodate in-person and hybrid site-visit processes, as determined by the needs and preferences of particular degree programs, the applicant institutions and PEQAB's External Expert Review Panels.
- 5. Repository of Non-Doctoral Terminal Credentials: Post on PEQAB's public-facing website a listing of the precedents for faculty terminal credentials and terminal credential packages for programs in which doctorates are either non-existent or impracticably rare.

PERFORMANCE MEASURES

The following performance measures track PEQAB's performance year over year, against its Perennial (1 & 2) and its Annual (3) Goals.

1. Satisfaction Levels

Establish performance goals against baseline results of PEQAB's 2022 Client Satisfaction Surveys, and track the results year-over-year.



2. Application Timelines

Report on results achieved against the Board's target goals of six months for a review of new programs/renewals and six months for amendments/conditions of consent.



3. Results Achieved against Annual Goals

Report on results achieved against the Board's previous annual goals, on a year-over-year basis.



REPORTING ON THE BOARD'S ANNUAL GOALS: 2022

 System Coordination Review: Apply Economic Need and Non-Duplication considerations to Program Reviews quality assured by the Board.

Progress: PEQAB has established a new standing committee to undertake System Coordination Reviews on behalf of the Board. System Coordination Reviews assess consent applications for new degree programs from Private and Out-of-Province organizations against the consideration of Economic Need and Non-Duplication.

2. Three-Year Degrees: Be prepared to quality assure any three-year degrees offered by Ontario Colleges which are referred by the Minister.

Progress: In consultation with the sector, the Board has established processes and review criteria to quality assure three-year degree programs offered at Ontario Colleges. The Board's process and criteria are articulated in its new *Manual for Ontario Colleges: Three-Year Degrees* and published to PEQAB's website in June 2022. PEQAB received and initiated Reviews of four (4) such late in 2022 and completed a recommendation to the Minister on (1) prior to year end.

 Improve Panel Orientation: Modify the Board's internal processes of orientating External Expert Review Panels to ensure greater consistency of interpretation.

Progress: The Board's internal process of orientating External Expert Review Panels has been updated to ensure greater consistency in the application of PEQAB's criteria in Panel Reports.

 Prior Learning Assessment: Examine and align PEQAB's advanced standing and PLAR benchmarks in the light of the Lisbon Recognition Convention.

Progress: PEQAB's advanced standing and Prior Learning Assessment benchmarks have been reviewed and are consistent with the expectations identified in the Lisbon Recognition Convention.

 Ontario Human Rights Code: Examine and align benchmarks related to academic freedom and codes of conduct with the Ontario Human Rights Code.

Progress: The Board's benchmarks related to academic freedom and codes of conduct have been reviewed in reference to the Ontario Human Rights Code; the results of this review will be presented for Board consideration in Spring 2023.

OTHER ACCOMPLISHMENTS: 2022

In 2022, the Board and its Secretariat completed the following initiatives and enhancements.

- * Honorary Degrees: The Board has adopted criteria for regulating honorary degrees in relationship to degrees under consent. This approach is now documented in the January 2023 edition of all PEQAB Manuals.
- * System Coordination Reviews: The Board has established a new System Coordination Review Committee and recruited members with relevant credentials to review applications for consent from private and out-of-province organizations in terms of economic need and non-duplication.
- * Scheduling of Organization Re-Reviews: The Board has published clarifications to the schedule of Organization Reviews in its Manual for Private, Out-of-Province and Other Organizations to align with the renewal of Organization Reviews with relevant Program Reviews.
- * Predetermination of Terminal Credentials: The Board has introduced a "predetermination" process for considering, in advance of a consent application, what the Board will accept as constituting the "terminal credential" for faculty in particular degree fields, especially where there are limited or no doctoral programs. In this connection, the Board has also adopted the concept of "terminal credential packages," i.e., a determination what combination of credentials held by an individual faculty member, normally in addition to a Masters degree, will comprise the terminal credential.
- * Appointment of Two New Breadth Reviewers: The Board welcomed Dr. Mireille McLaughlin and Dr. Jacques Paul Couturier to its standing Breadth Review Committee, particularly to accommodate Breadth Reviews for French language postsecondary programs.

PEQAB TIMELINES

PEQAB timelines for the review of applications are calculated from the application's *referral* to its *recommendation* date, and reported here based on the calendar year in which the Board makes its recommendation. Timelines are averaged and exclude delays in the review process initiated or approved by applicant institutions.


Results from PEQAB's client survey demonstrate exceptional levels of satisfaction among educational institutions and independent academics who review the quality of degree level programming offered in Ontario.



Q1: How satisfied have you been with the **quality/usefulness** of the responses you received from PEQAB Secretariat staff?




Q2: How satisfied have you been with the **timeliness** of the response you received from PEQAB Secretariat staff?









Q1: How satisfied have you been with the **quality/usefulness** of the responses you received from PEQAB Secretariat staff?




Q2: How satisfied have you been with the **timeliness** of the response you received from PEQAB Secretariat staff?









Q1: How satisfied have you been with the **quality/usefulness** of the support you received from PEQAB Secretariat staff?




Q2: How satisfied have you been with the **timeliness** of the support you received from PEQAB Secretariat staff?
